Terms and Conditions of Entry (Game of Chance)**

<b>Name of Competition</b>	2023 Runaway Marathon Series Promotion

<b>Notification of Winners, Prize Delivery</b>	<p>Each Winner will be notified in writing by email within 48 hours of the relevant draw. Prizes will be delivered/transferred to all Winners within 28 days of the completion of the Competition Period. <b>Unclaimed Prizes</b>	<p>All prizes will be distributed during or after the close of the Competition. The Promoter will make reasonable efforts to identify and locate the Prize winner.</p> <p>If any Prizes (other than perishable prizes) remain unclaimed within 3 months after the Prize Draw, an unclaimed prize draw will be held at Promoter's office 3 months after the Prize Draw subject to the approval of any necessary regulatory authority ("<b>Unclaimed Prize Draw</b>"). Winners of the Unclaimed Prize Draw will be notified in the same manner as set out above. Winners names will be published in the same manner as set out above.</p>

  - the Prize or use of the Prize.

The Promoter reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Competition or to be acting in violation of these Terms and Conditions, or in an improper manner. Any attempt by any person to undermine the legitimate operation of the Competition may be a violation of criminal and civil law, and, if such an attempt is made, the Promoter reserves the right to seek damages from any such person to the fullest extent permitted by law. The Promoter's failure to enforce any provision or aspect of these Terms and Conditions shall not constitute a waiver thereof.
- All issues and questions concerning the construction, validity, interpretation, or enforceability of these Terms and Conditions, or the rights and obligations of the entrant and the Promoter in connection with the Competition, shall be governed by, and construed in accordance with, the laws of the State of Victoria, Australia nominated by the Promoter, without giving effect to any choice of law or conflict of law rules that would result in the application of the laws of any other jurisdiction. Entrant agrees that any and all disputes, claims and causes of action arising out of or connected with this Competition, or any prizes awarded or not awarded shall be resolved solely individually, without resort to any form of class action, and exclusively by the appropriate court located in the capital city of such State.
